



## **APPLICATION-NON-TRADITIONAL FEMALE STUDENT- 2026**

### **Criteria:**

- Applicant is a female who has a high school diploma or GED/HSED.
- Applicant lives or works in the Amery School District.
- Applicant plans to attend (or is already attending) an accredited college, university, technical college, or other accredited post-secondary training to complete an undergraduate program. Documentation of enrollment is required.
- Applicant may be a part-time or full-time student.
- Applicant must earn no more than 150% of the 2026 federal poverty guidelines based on household size: (1) \$23,940; (2) \$32,460; (3) \$40,980; (4) \$49,500; (5) \$58,020; (6) \$66,540; (7) \$75,060; (8) \$83,580. For families or households with more than 8 persons, add \$8,520 to the 150 % limit for each additional household member. (Source: <https://aspe.hhs.gov/poverty-guidelines>)
- Scholarship money may be used toward tuition, books, childcare, and transportation.

### **Your application MUST include the following:**

- 1) Cover sheet (attached to the essay or letter in #2) with:
  - a. Your Name, Address, Telephone Number, and Email Address.
  - b. Name and Address of the educational institution you are attending or planning to attend.
  - c. Program you are/will be enrolled in.
  - d. Adjusted gross income for the previous year.
- 2) An essay or letter describing your need for the scholarship and how your education will improve your life and your community.
- 3) One letter of recommendation from anyone not related to you. This letter should verify your need and how serious you are about completing your educational goals.
